Manuel has been asked to design a sticker to go on resident's car windshields. These will be seen by the guards easier than the current ones that hang on car mirrors.

Water -No problems.

Animal Issues – Ongoing, residents still setting traps.

c) Legal Update -

- d) Non Colonos Payers Michael stated that we have had several non payers looking at paying up so they can get Fiber Optic Internet. Discussed notice to non payers. There has been no time to work on this due to the Fiber installs and planning for the AGM.
- e) SIMAPA Sewage Holding Tank

Cumbres has been removed from our holding tank. Simapa has asked CVN to wait until they get Cumbres sorted before dealing with CVN.
