**1.** <u>Call to Order</u> – Michael Richard Thompson, President, called the meeting to order at 10:02 AM.

**4.** Treasurer's Report: Al Borchardt presented the financial report as of the end of July 2020.

Total Income was \$117,228 MXN.

Operating Expenses \$212,282 MXN over budget. (Onetime payment to CFE of \$261,581 to cover last 7 years for street lamps.)

Maintenance Expenses \$16,076 MXN under budget. (\$4,757 for pump maintenance and cleaning).

Total Expenses for Month were \$204,763 MXN over budget.

Operating cash in Banks - \$939,213 MXN Emergency Fund - \$749,200 MXN Security Deposits - \$371,500 MXN

- c) Non Colonos Payers no update.
- d) <u>SIMAPA</u> Sewage Holding Tank CVN is still trying to get a meeting with Cumbres. Simapa and CVN have come to an agreement but need Cumbres to accept their portion of the cost.
- e) Solar Panels for Office Final document signed yesterday, CFE to hook up new meter.
- f) Signing Authority at Bank On hold till after AGM.
- g) <u>Upcoming AGM</u> Delayed due to Covid-19. Herma suggested that Michael send a Presidents Report to all residents as this is normally done at the annual AGM. CVN is still unsure of how long we will have to wait to hold an AGM. Michael to work on this over the next week.
- h) Changes to Bylaws and Rules and Regulations Nothing new.

## 8. New Business

a) Michael, Hortencia and John Brennan met with CFE 3 times during the last month. When CFE provided their estimate of the cost of electricity to run our street lights it did not add up, no way could the lights use the amount of electricity reported. They quickly came to the conclusion that some homes within CVN have directly hooked up (no meters). CFE will have to look into this. An amount was agreed to cover the last 7 years and CVN paid for the back electricity. After negotiation, CVN paid \$249,262 MXN, over \$200,000 MXN less that the amount CFE was originally asking for (\$473,918 MXN). CFE will bill CVN yearly for electricity used to power street lights. This will be estimated annually. CVN has agreed not to go with solar street lights for the foreseeable future.
