We are short \$75,053MXN total income for the year. We should be above budget by years end.

Maintenance Expenses \$8,966 MXN under budget.

Total Expenses for Month were \$55,843 MXN under budget.

Security Deposits - \$371,500 MXN

Simapa has agreed to pay 35% and CVN was trying to get Cumbres to agree to divide 65% between CVN and Cumbres. Currently Cumbres is willing to accept the following: 35% Simapa, 28.5% Cumbres and 36.5% CVN. CVN is still trying to negotiate with Cumbres but needs a vote on whether we pay this amount if not able to negotiate with Cumbres.

MOTION: To negotiate with Cumbres to get them to accept a higher percentage but agree to accept the above division if unable to get them to accept more.

Discussion was held with regards to Michael's draft Presidents Report. Several suggestions were made with regards to additions and minor changes.
