- c) Budget for 2021. Al showed a proposed budget for 2021 that would have an over spend of \$231,009 MXN. Herma raised an objection to any budget that showed a loss and is not balanced. Al believes that there is enough in reserve to cover the over spend for 2021. Michael refused to consider an increase to the fees for 2021. Herma recommended that in future years we at least consider a small cost of living increase, as every year salaries, services and goods go up in cost. Herma asked that we add 50,000 revenue for fibre optics this would at least bring the budget a little closer to balanced. We will vote on the budget after the next meeting when we have the final year financials.
